

## Clinton County Fair 2026

Dearest friends and vendors:

It is always an exciting time of year as we begin to plan for the fair season. The 53<sup>rd</sup> Clinton County Fair will be held August 1-8, 2026. We encourage you to decorate with red, white and blue and display flags, to recognize the 2026 PSACF theme, 'Celebrating 250 Years of Freedom, Family & Fairs'. How exciting!

The basic vendor fees remain the same for 2026. Camping fees increased to \$150 for the week. New this year is an additional fee for trailers/campers that arrive before Wednesday July 29. (see contract for details).

I am asking, ok begging, that you complete your paperwork. This includes listing all required information on the contract. List, or provide a copy of all the items you plan to sell. Keep this letter as a reference, and thank you in advance for your attention to these details. It saves time when you arrive.

- Be sure contract is complete with ALL items being sold or displayed listed.

(Do not state same as last year)

- Include your tax ID and ServSafe numbers (if a food vendor).
- Sign **both** pages of the contract.
- Insurance forms must have the Clinton County Fair listed as 'additionally insured' with the physical address of the fair. 98 Racetrack Road, Mill Hall, PA 17751.
- Include the AMP needed for your trailers/campers. This prevents problems when moving in!
- Passes are **not** mailed but can be picked up at the fair office **when you check-in**.
- All vendors are asked to check in with vendor chairman prior to setting up.**
- Free demonstrations are offered during fair week. Please ask me if you would like to do this.
- Move in: Wednesday & Thursday 1PM – 9PM and Friday 9AM - 9PM (the week preceding the fair)
- Move out: **AFTER** the close of fair Saturday night 10:00 PM or Sunday and Monday After the fair)  
from 8 am – 4 pm ALL items must be removed by 4 pm Monday following the fair.
- All Vendors are required to be open by 10 AM on the weekends, Tuesday Aug 4<sup>th</sup> (Senior Citizen's Day) and Wednesday Aug 5<sup>th</sup>, (Kiddies Day) 2024 and then by 3:00 PM the other weekdays. You are encouraged to be open every day for those on the grounds.**

❑ Final payment is due Monday August 3, 2026.
